- Those ILP Applicants coming from the State of Assam i.e. Karimganj, Hailikandi, Dima Hasao and Karbi Anglong will be required to produce National Register of Citizens (NRC) in addition to the documents cited above.
- The system of issuing ILP in online mode shall be introduced immediately wherever feasible and all issuance of ILP in off-line mode shall be discontinued w.e.f. 31st December 2024. All concerned Officers shall ensure that facilitation counters for providing necessary assistance.
- For any clarifications on ILP issuance, the Commissioner Nagaland will refer the matter to the Home Department whose decision will be final.
