NO.CON-3/PAP/65/10 :: In exercise of the powers conferred under Section 4 of the Bengal Eastern Frontier Regulation, 1873 and in partial modification of notification of even number dated 03/05/2018; the Governor of Nagaland is pleased to revise the validity period and the fee structure for issuance of Inner Line Permits for various categories and certain other conditions as under:

1	Tourist (Indian)	50 100	15 days 30 days	Election documents & other documents as prescribed by the Govt. from time to time No Guarantor
2	Tourist (Foreigners)	50 100	15 days 30 days	Valid Indian Visa / Passport No Guarantor
3	Trader/Businessman	500	1 year	Local Guarantor, and a certificate from the concerned administrative officer that the applicant has been continuously residing in Nagaland for more than 1(one) year at the time of application
		100	3 months	Local Guarantor, and if the applicant is residing continuously in Nagaland for less than 1 (one) year at the time of application.
4	Labourer	100	3 months	Local Guarantor
5	Priest / Teacher	500	1 year	Local Guarantor
6	Student	100	3 months	Registration certificate from the concerned Institution situated in Nagaland for getting an ILP initially, and subsequently the Valid Identity Card issued by the concerned Institution shall be considered as deemed Inner Line Permit (ILP)

2. In addition to the existing mode of obtaining ILPs, the facility of online application and issue of online ILP for the category of applicants at serial 3, 4, 5 and 6 in the above para, will be made available from a date to be notified later.

The process of renewal of Inner Line Permit, where the validity period is 1(one) year may be initiated by the applicant 30 (thirty) days before the due date of expiry of ILP.

4. All other terms and conditions will remain the same as in the earlier notification of even number dated 03/05/2018 on the same subject.
5. This notification shall come into force with immediate effect.
