NO.CON-3/PAP/65/10 :: In exercise of the powers conferred by Section (4) of the Bengal Eastern Frontier Regulation, 1873 and in supercession of earlier notifications regulating the prescribed fees for issuance of Inner Line permits to non-indigenous persons crossing the inner line in the State of Nagaland, the Governor of Nagaland is pleased to revise the fees for issuance of Inner Line Permits to such persons. The fee structure for various categories of Inner Line permits shall be hereby revised as follows:

| 3 | Traders /Labourers | 100 | 3 months | Local Guarantor |
| 4 | Priest /Teachers | 500 | 1 year | Local Guarantor |
| 5 | Students | 100 | 1 year | Registration certificate from the concerned Institution |

2. ILP for Applicants from 4 (Four) districts in Assam:

ILP application from Karimganj, Hailkandi, Dima Hasao & Karbi Anglong shall be issued by concerned Deputy Commissioner after the documents of the applicants from the above districts are verified by the Inspector General of Police (INT), Nagaland.

3. Online System of ILP:

Online system of ILP permit should be restricted to Tourists only.

4. Sponsorship for issue of ILP:

A local person can sponsor upto 10(ten) applicants for issue of ILP. Beyond that the matter shall be referred to Commissioner Nagaland, who will examine the merit and decide on grant of ILP in light of justification submitted by the sponsor.

i. The employee of the Central and State Government shall be exempt from provision of ILP.

ii. Bonafide residents of Manipur State passing through Nagaland will be exempted while travelling through the State.

5. All other terms and conditions would remain the same.

6. This notification shall take effect from the date of publication in the official gazette.
